



Standard Choice Form and how to choose Flexible Lifetime[®] - Super

If you are eligible to make a choice under Choice of Fund legislation your employer is required to give you a Standard Choice Form.

If Flexible Lifetime - Super (FLS) is nominated as the default fund in Section B, Question 6, you do not need to do anything - your super will be paid into FLS.

However, if FLS is not nominated as your default fund and you want your employer to pay your super contributions into FLS, you need to complete the Standard Choice Form and return it to your employer.

Generally, to be eligible to choose FLS you need to be able to answer yes to one of the following questions:

Has your employer listed FLS as the fund where contributions had been paid to previously in Section B, Question 8 of the Standard Choice Form? (This means that your employer was previously contributing on your behalf to FLS.)	► Yes	Complete Section A Question 1 Tick "my employer's previous superannuation fund named in Section B, Question 8". Question 4 Fill in your details and sign and date the form.
Are you a member of FLS because you have another employer that pays contributions on your behalf to FLS?	► Yes	Complete Section A Please note, to choose FLS you must already be a member. Choice of superannuation fund - information from the trustee of FLS

This document gives you all the information you are required to give to your employer with your completed Standard Choice Form. Please attach this letter to your Standard Choice Form as required in Section A, Question 3 and return to your employer.

Statement from the trustee that FLS is a complying superannuation fund and will accept contributions from your employer

FLS is a superannuation product within the AMP Superannuation Savings Trust. AMP Superannuation Limited, in its capacity as trustee certifies that the AMP Superannuation Savings Trust:

- Is a complying superannuation fund and is a resident regulated superannuation fund within the meaning of the Superannuation Industry (Supervision) Act 1993 (SIS).
- Is not subject to a direction under section 63 of SIS, and
- Will accept contributions from an employer, provided the employee is already a member of FLS.

How an employer can make contributions to FLS

Cheque or money order

Employers can pay by cheque or money order payable to "AMP Life Limited - FLS". Details of the relevant employee (including member number) must be included as well as a break-up of the payment by contribution type.

Existing FLS employers

If an employer already has an active employer account they can make contributions through their existing arrangements, such as online through AMP eSuper or BPay.
